

**CONSENT TO THE PROCESSING OF PERSONAL DATA
PARTICIPANT OF THE FOREIGN INTERNSHIP PROGRAM ERASMUS +**

- I consent to the processing (including transfer to a country outside the European Economic Area, if there is an internship in that country) my personal data contained in the application form and documents submitted by me in order to participate in the Erasmus + internship program by the University of Economics in Krakow with headquarters in Krakow, ul. Rakowicka 27, 31-510 Kraków and I declare that the provision of my personal data is voluntary and that I have been informed about the right to request access to my personal data, rectify it, delete it or limit its processing.
- I consent to the processing of my personal data in the form of an image for the purpose of recruiting, promoting and disseminating the results of the Erasmus + internship program, by the Cracow University of Economics with its seat in Krakow, ul. Rakowicka 27, 31-510 Kraków and I declare that the provision of my personal data in the form of an image is voluntary and that I have been informed about the right to request access to my personal data, rectify it, delete it or limit its processing.

Information clause regarding the processing of personal data:

Pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (general regulation on the protection of data - GDPR, Journal of Laws UE L 2016, No. 119), we would like to inform you that:

1. The administrator of your personal data is the University of Economics in Krakow, ul. Rakowicka 27, 31-510 Kraków (hereinafter UEK or administrator)
2. Contact details for the personal data inspector appointed by us: e-mail: iod@uek.krakow.pl.
3. Your personal data contained in the application form and documents required by the internship organizer will be used for the purposes of recruitment and implementation of the internship program, its reporting and control, as well as promotion, dissemination of results and preparation of statistical reports.
4. The legal basis for the processing of your personal data is your consent (Article 6 (1) (a) of the GDPR), as well as the legitimate interest of UEK, i.e. promotion and dissemination of the results of the foreign internship program (Article 6 (1) (f) of the GDPR) and EUK's fulfillment of legal obligations resulting from the provisions of Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of individuals with regard to the processing of personal data by EU institutions, bodies and offices and on the free movement of such data and repealing Regulation (EC) No 45/2001 (Article 6 (1) (c) of the GDPR).
5. The recipients of your personal data may be external entities dealing with IT or legal services for the administrator, control institutions authorized to verify the correctness of the program implementation and external entities handling the Erasmus + program on behalf of the European Commission.
6. Your personal data will be stored for a period of 7 years from its transfer, and then deleted within 1 year.
7. You have the right to withdraw your consent to the processing of personal data at any time. Withdrawal of consent will not affect the lawfulness of the processing which was carried out on the basis of consent before its withdrawal. You have the right to request access to your data, rectification, deletion, processing restrictions, as well as the right to object to the processing of your personal data, for reasons related to your particular situation, in cases where we process your personal data on the basis of our legitimate interest.

8. Providing personal data is voluntary, but necessary to participate in the recruitment process for the internship program. Failure to provide us with personal data or withdraw consent to their processing prevents participation in the Erasmus + internship program.
9. If you believe that we are processing your personal data in an unauthorized manner, you have the right to lodge a complaint with the supervisory authority regarding personal data.
10. Your personal data in the form of an image may be posted on the website www.kariery.uek.krakow.pl, www.kariery.uek.krakow.pl, on the accounts of the Academic Career Center and the University of Economics in social networks: Facebook, Instagram, LinkedIn and YouTube, and the "Kurier UEK" magazine.
11. Your personal data may be transferred to third countries due to the international nature of the program, for its implementation: through the Mobility Tool portal (http://ec.europa.eu/education/resources/mobility-tool_en) and the OLS portal (<http://erasmusplusols.eu>).
